Please note: the hall has carpet tiles. For tiles that are damaged or greasy by cars or parts, we have to charge the exhibitor € 8.50 per tile on behalf of the exhibition hall. We make cardboard plates available for underneath cars or parts. At the end of the fair you have to dispose of your leftovers. Material left behind will be removed at your expense. The costs are € 17,50 per kilogram.

1. The request to rent space can be made by submitting the appropriate registration form, in which reference is made to our terms and conditions. The applicant for space agrees to the general terms and conditions. It concerns only cars, parts and goods or activities related to the brands Citroën and Panhard.
2. The allocation of space will be carried out by the organisation according to the order in which reservations are received and the layout will be as much as possible in accordance with the wishes of the participant. If the desired space has already been rented out, other space will be allocated if possible.
3. The organisers reserve the right, without being obliged to give a reason, to refuse requests for space rental.
4. The organization reserves the right, due to special circumstances beyond its control (force majeure in the broadest sense of the word such as fire, national disaster, etc.), to cancel the exhibition, or the dates for modify the exhibition, without in such cases participants, regardless of whether space has already been allocated to them, being able to claim compensation from the organisers for any damage, in whatever form or howsoever arising.
  - 5a. If, in the opinion of the organisation, special circumstances justify this, the organisation may change the dates set for the exhibition or cancel an already established exhibition.
  - 5b. Special circumstances as referred to in point 5a. include insufficient interest, insufficiently representative offer, mutual disagreement in the branch concerned and all those circumstances which, in the opinion of the organisation, after weighing up the interest, could jeopardise the success of the fair.
  - 5c. Under no circumstances can the participant assert against the organisation any right to compensation, in any case, as a result of a decision, as described in paragraph 5a of these terms and conditions.
6. If the exhibition does not take place as referred to under points 4 and 5, the registrations and any space allocations already made will automatically be considered expired and the payments made by the registrants in respect of the exhibition will be refunded. When the exhibition is held on changed dates, therefore when the fixed dates are changed, the participation agreement remains in full force.
7. Exclusivity will not be granted except in special cases to be assessed by the organisers. The applicant will always and exclusively be informed in writing whether or not exclusivity will be granted.
8. The organisation has the right to make changes to rooms already allocated, if this should prove necessary for organisational reasons, without the entrant being entitled to compensation for damage, in whatever form or by whatever cause that may have occurred.
9. The space rental fee must be paid within 2 weeks after receipt of the invoice; failing which the organisers shall be entitled to withdraw the allocation of space already granted. In the event of revocation of the allocation of space granted, the organisation shall retain the right to full compensation of the relevant amount.
10. Subletting or transfer of space is not permitted, nor is the free transfer of space to third parties, unless explicitly permitted in writing by the organisation.
11. A registration cannot be withdrawn or changed unilaterally by the participant. The organisation may grant a request for cancellation of the registration, on condition that the participant concerned pays a cancellation fee. This fee amounts to 0% of the rent if one cancels before 1 April of the year in which the event takes place. If cancelled after 1 April of the year in which the event takes place, 50% of the rent is due.
12. The use of sound installations for whatever purpose is permitted only in consultation with the organisation, subject to reservation. Requests will be assessed by the organisation. It is not allowed to affix notes or other advertising material to columns, walls, trusses, etc. in the hall. It is not allowed to place exhibited goods and/or advertising material outside the rented space or to distribute advertising materials in and around the hall. Any costs of removing tickets and advertising material shall be recovered from the party who affixed the tickets and advertising material and/or from the party named in the tickets and advertising material.

13. Nails shall not be nailed to the walls or floors, nor drilled holes in them, nor made any provision which could damage them. Damaged carpet tiles must be compensated. The cost per tile is € 8.50 excluding VAT. The organisation makes cardboard sheets available free of charge. These boards serve to protect the floor covering. At the end of the fair, the exhibitor is obliged to dispose of rubbish in the appropriate container. For garbage left behind, € 17.50 excl. VAT per kilo will be charged.
14. The hirer of space is obliged to repair the damage caused by his/her actions and is fully liable for the possible costs of repairing the damage caused by his/her actions.
15. Demonstrations within the room are allowed. Oxygen or other gas cylinders may not be used in any demonstrations.
16. All participants' entries to the Exhibition are at their own expense and risk, the organisers are under no circumstances and in no way liable for damage to or loss of any property belonging to the participant, regardless of the event that caused the damage or loss.
17. In the case of constructions, prior permission is required from the organisation and from the Building and Housing Department. A written approval of the latter must be submitted to the organisation by the Building and Housing Department. The participant must take additional costs into account.
18. Before vehicles, implements powered by fuel engines are introduced into the hall, the fuel tanks must contain a minimum amount of fuel, pipes must be emptied and the tanks must be properly sealed. These tanks shall remain closed as long as the vehicles are present in the hall. Battery clamps shall be disconnected. A cardboard plate shall be placed under the engine compartment. Greasy parts must also be laid down on cardboard plates. See Article 13.
19. The lessee is obliged to follow the instructions of or on behalf of the organisation and/or fire brigade with regard to the construction, layout and dismantling of the stand.
20. The organisation is not responsible for the proper functioning of any technical installation, nor of any part of it or of the hall and cannot be held liable for any damage in whatever form that may have been caused to the participant
21. The maximum permissible load on the floor of the hall is 1000kg/m<sup>2</sup>. The maximum allowed wheel pressure is 2500kg, or 10.000kg per axle.
22. The hall is available for erection during the times indicated. In order to avoid inconvenience to other participants, large and/or heavy goods must be placed in and/or on the stands in good time.
23. For the hall, the stands can be connected to the electrical circuit of the hall (voltage 220/240 volts at 50 Hz), provided that these connections are made by a qualified fitter or on the instructions of the organisation. Own energy generation by means of separate installed generators and the like are not permitted. The stand installations must comply with the regulations of the municipal energy company and will be inspected before being connected. For information, please consult the registration form
24. The participant is liable for any damage caused by him/her or for any damage attributable to him/her and is obliged to insure himself/herself against any damage of whatever nature caused by the actions or negligence of him/herself or his/her staff or third parties.
25. All agreements are governed by Dutch law and are subject to the exclusive jurisdiction of the Dutch courts.
26. In all cases not provided for in these terms and conditions, the organisation decides.
27. The English, German and French texts are a translation of the applicable terms and conditions drawn up in the Dutch language. The Dutch text of the terms and conditions is binding and leading, even in the event of a difference in the text or a difference in interpretation or interpretation of the terms and conditions.
